	<p><b><u>Chairs Welcome</u></b></p> <p>Welcome to everyone.</p> <p>In the last 3 weeks Cllr McLeod reported the following:</p> <ul style="list-style-type: none"><li>• Met with James Naish MP with regard to what is happening with the British legion. Correspondence has been shared on the council website to note the car park will be closed and the site secured.</li><li>• Attended a meeting with several other councillors to discuss the future of the middle of the village.</li><li>• Attended the Radpanto - which was fun.</li><li>• There have been many finance meetings to look at the budget in depth</li></ul>
	<p><b><u>Open Forum</u></b></p> <p>Four members of the public wished to comment:</p> <ol style="list-style-type: none"><li>1. Long standing resident of Radcliffe wished to raise concerns with regard to the precept request. They made comments that the precept increased in the last 5 years 18% with this year to be 182% increase which is unsatisfactory. Concerns with regard to the 2025-26 budgeting errors. Comments were raised</li></ol>

	<p>with regards to the neighbouring areas not increasing their budgets to the same level, why is Radcliffe different?</p> <ol style="list-style-type: none"> <li>2. Raised concerns for a 200% increase</li> <li>3. Resident acknowledged that they read the documents online and can understand the approach however questions whether there is a duty to not place the burden on the residents. They also asked a number of questions: What is the actual percentage increase? What is the financial impact on each band? Has there been any consultation on the new approach? Has there been an assessment of the impact on low income households? What guarantees can residents expect for the money?</li> <li>4. Resident wished to raise comments with regard to the planning application 25/01373/FUL they have taken out the issues with the fisherman's layby but have yet to address the PCs other objections.</li> </ol> <p>They also wished to compliment the budget, it has been done professionally with a substantive asset register and thank you. However, no sympathy for the mess which has been of own making. Questions were raised with regard to whether other options sought to lessen the burden especially on low income families.</p>
	<p><b><u>Reports from Borough and County Councillors</u></b></p> <p>NCC Cllr Upton reported that a petition of 2500 signatures for the greenway has now been presented to Government by James Naish MP, and they wish to present to Full Council at Nottinghamshire County Council. NCC are trying to get the greenway re-opened. There are also other flooding issues at the Harlequin estate, they are being investigated.</p> <p>RBC Cllr Clarke reported the Local Government Reorganisation proposal has gone to Government and is now being considered with a response expected in the new year and consultation to take place. He also reported flooding feedback for Clumber Drive, all work has taken place with a major positive effect. The system coped with recent heavy rainfall.</p>

The Executive officer showed the Council the yearly increases, - with 10 years having an increase of less than 1% in the last 20</p>

	<p>years. There are over £6m worth of assets that the Parish Council own and/or maintain. This budget incorporates maintenance for assets and a percentage of capital saving for the asset replacement when it comes to the end of useful life.
