	<p><u>Chairs Welcome</u></p> <p>Welcome and happy new year.</p> <p>I would like to congratulate Mark Greenhalgh who was honoured in the Kings Honours list and awarded the British Empire Medal for his many years working with young people across Nottingham with the Duke of Edinburgh awards, he also was involved in the Methodist Church mini bus.</p> <p>Also, happy to report that the health centre project is progressing.</p>
	<p><u>Open Forum</u></p> <p>One member of the public wished to thank the grounds team and probation service for how Rockley Memorial Park is looking, it is much appreciated.</p> <p>They also wanted to question whether in the CIL strategy item later on whether the Rockley Memorial pavilion is an appropriate spend of CIL money and why not other assets.</p> <p>Also wished to comment about the footprints seen on the frozen Lily pond and expressed concern for anyone who ventured onto the ice. They requested that signage be placed in the area to warn members of the public of the risks.</p>
	<p><u>Reports from Borough and County Councillors</u></p> <p>RBC Cllr Neil Clarke reported the Legion car park has been blocked off to protect the land from unwanted infiltrators.</p> <p>National Highways have also put in concrete blocks on the A52 to limit access to land off the A52. The embankbank (Greenway) is still ongoing.</p> <p>The health centre is close to going to planning applications.</p> <p>Cllr Neil also pleaded to be careful when out in icy conditions.</p>

FC26-236	<p><u>To consider and approve the proposal to adopt the CIL and Capital spend strategy</u> The Council resolved unanimously to adopt a CIL spend strategy, with the amendment to remove Capital spend elements of the strategy. Cllr Mills requested that a project group be formed to look at the restoration of the Rockley Memorial Pavilion.</p>
FC26-237	<p><u>To receive and note reports from members</u> Cllr Furniss reported that Spitfire Homes have replied positively to the request of a noticeboard and defibrillator and bleed kit at Sherbourne development.</p>
FC26-238	<p><u>To consider comments on the following Planning applications:- (planning and your role as ward member)</u></p> <p>a) <u>25/01971/FUL Raised ridge and hip to gable extension to existing house. Replacement detached garage42A Cropwell Road Radcliffe On Trent Nottinghamshire NG12 2FS</u> The Council resolved they do not object to this application but would ask that they are mindful of any bats. - carried (12 for 2 abstentions)</p>

b) **25/02107/FUL Single storey rear extension to dwelling 25 Hunt Close Radcliffe On Trent Nottinghamshire NG12 2EQ**
 The Council resolved to comment they do not object to this application - carried (12 for 2 abstentions)

c) **25/02116/FUL Single storey extension side and rear extension includes roof lanterns, new front porch with new canopy roof. Conversion of existing garage includes new monopitch roof. Alterations to fenestration. 6 Stanford Gardens Radcliffe On Trent Nottinghamshire NG12 1AB**
 The Council resolved to comment they do not object to this application - carried (12 for 2 abstentions)

d) **25/02070/ADV Display of 3no. front fascia signs and 1no. rear fascia sign 11 Bingham Road Radcliffe On Trent Nottinghamshire NG12 2FY**
 The Council resolved to comment an objection on the grounds of:
 Failure to follow the Rushcliffe Design Code (2025): The applicant has not submitted the mandatory Compliance Checklist. Without this, they have failed to prove that the sign meets the new 2025 standards for high-quality shopfronts.
 Inappropriate Materials (Aluminium): The use of industrial aluminium is contrary to Policy 12 of the Radcliffe on Trent Neighbourhood Plan. While the building is modern, we must move toward higher-quality materials that protect our "village feel" rather than repeating past design mistakes with utilitarian metallic finishes.
 Harm to Local Amenity (NPPF Para 136): Under the National Planning Policy Framework, signage must respect local "amenity." This aluminium signage is visually dominant and industrial in nature, which harms the character of the streetscene and fails to "preserve or enhance" the village centre.
 Neglect of Local Character: The proposal ignores the requirement in the Rushcliffe Design Code for signage to be proportionate and sympathetic. We request a move away from "standardised" corporate aluminium toward bespoke finishes that suit Radcliffe's unique identity.

e) **25/02141/TPO T1 on sketch plan (T28 on tree report)- 1x (Ash) - Twin stemmed - fell Millfield House 74 Cropwell Road Radcliffe On Trent Nottinghamshire NG12 2JG**
 The Council resolved to comment do not object to this application subject to the tree officer but would request a new tree is planted - carried (12 for 2 abstentions)
